## Raids fail to stop pirate broadcasts

The Government is "clearly losing the war" against unlicensed radio stations, according to a report prepared by the Community Radio Association.

The association, which is opposed to unlicensed broadcasting, says 115 radio "pirates" have been on the air since July 1.

Sixty-five of the stations have been monitored in London, another 21 on Merseyside, and the remainder are scattered throughout the country.

Mr John Butcher, Under Secretary of State at the Department of Trade and Industry responsible for the Radio Investigation Service, told Parliament last month that 218 raids had been made on 84 unlicensed stations in the 12 months to mid-November.

He said 39 of the stations were in London, 14 on Merseyside and the remainder in Sussex, Birmingham, North Wales, Telford, north Hertfordshire, Rugby and Basildon.

Mr Butcher said that officials had raided PCRL, an unlicenced station in Birmingham, more than 30 times.

When the Government withdrew, in June, its plan to introduce a new community radio service, the Community Radio Association said that the decision would lead to an increase in the number of unlicensed stations.

"This is exactly what has happened over the last six months," the report said.

Solar Radio, a London station that closed down voluntarily in 1985 to apply for a licence, is among those that have returned to the air, and is broadcasting on VHF on a 24-hour schedule.

There are eight 24-hour pirate stations operating in London, with more expected to go on the air soon, the report said.

In spite of a number of raids in the London area on December 22, all were back on the air by Christmas Eve, when monitors picked up transmissions from 14 stations.
