The Department of Trade's powers to close down pirate radio stations were drastically cut yesterday when five Law Lords unanimously ruled that the Department did not possess the powers to confiscate records and tapes from pirate stations convicted of broadcasting without a licence.

They upheld a court of appeal ruling that records and tapes were not broadcasting "apparatus" under the 1949 wireless telegraphy act.

A department spokesman said later: "Records and tapes are often the most expensive part of their equipment—transmitters being worth only pennies in comparison." A pirate station where only the transmitter was confiscated had been closed down about 100 times but was back on the air each time within days.

"This ruling removes an im-portant economic weapon from the enforcement authori-

ties," she said. New legislation might be needed.

The Law Lords' decision means that Jeffrey Rudd, of Liverpool, who pleaded gullty in 1985 to two charges of breaching the 1949 act, will now get back his collection of 310 discs and tapes, including some unique and rare recordings.

Mr Rudd, who had been illegally broadcasting from his home in Finchley Road, Anfield, was fined £100, plus

f40 costs, by Liverpool city magistrates in November 1964. The magistrates confiscated his broadcasting "apparatus," worth £3,000, including his radio transmitter, tape decks, record turntables, microphones, speakers and the records and tapes.

Mr Rudd took his case for the return of his music collection to the Court of appeal, which ruled in his favour in April last year.

The DTI appealed to the

Lords because similar forfeiture orders had been made by magistrates all over the country and it was not clear what powers they had in such cases. Dismissing the Department's appeal Lord Goff sitting with Lord Bridge, Lord Brandon, Lord Mackay and Lord Ackner, said: "I recognise this conclusion may create problems for the enforcing

Mr Rudd was awarded costs against the DTI.
