

AS I TYPE THIS IT IS A HOT SUMMERS DAY AT THE END OF MAY, AND BEFORE ME ARE THE LATEST NEWSPAPER CUTTINGS; THE FIRST ONE READS: 'RTE LICENCE ILLEGAL CLAIMS "PIRATE" RADIO' AND GOES ON TO INFORM US THAT DURING THE RECENT ARD COURT CASE, IT WAS CLAIMED BY MR. MCCARTON (FOR ARD) THAT IF RTE HOLDS A BROADCASTING LICENCE FROM THE MINISTER, AS IT SHOULD UNDER THE ACT, IT IS UNLAWFULLY HELD BECAUSE THERE IS NO MACHINERY BY WHICH THE MINISTER COULD HAVE GRANTED IT IN THE FIRST PLACE. THE BIG D has been operating continuously - only going off the air for 90 minutes for aerial maintanence. The estimated listenership stands at about 210,000 per day and

with the notable exception of the HOT PRESS. When the secession occoured, we did not make public any of the unfortunate e events which had forced us to leave RADIO DUBLIN. Mr. Cooke himself was the only person who made these facts public and we would prefer to forget the mass of allegations and counter allegations which occoured during the week, and say that 34 people do not resign for either flippant or specious reasons.

ARD chief fined £25 after query on RTE's legality

The claim had been made when so." a director of Alternative Radio Dublin (ARD) was fined £25 and had radio equipment confiscated for having it without a licence.

Bernard Llewellyn of Walnut Rose, Dublin, admitted possessing a radio amplifier and oscillator at Belvedere Place, Dublin, on January 31 without a licence.

Det. Sgt. Bernard McLaughlin, and attached to the Investigations Branch of the Department, said he discovered the equipment during a search. He heard somebody say: "ARD is now being closed due to a raid."

Asked by Mr. Padraig McCartan, B.L., for ARD, if he was aware that RTE did not have a licence either, Det. Sgt. McLaughlin replied: "I don't know. I've never called on them."

Mr. McCartan said the 1926 Act set up machinery by which the Minister for Posts and Telegraphs would issue licences for broadcasting. It also provided that regulations would be made by the Minister to put that machinery into operation. Those regulations had not been made.

If the national broadcasting service held a broadcasting licence from the Minister, then it held it unlawfully as there was no machinery by which the Minister could have issued it in the

> In court Mr. Erwin Mill-Arden, B.L., for the Department, said the Broadcasting Authority Act 1960 stated: 'The Authority shall establish and maintain a national television and sound broadcasting service nd shall have all powers necessary for this."

And last night a spokesman for the Department said RTE of the Central Detective Unit, had a broadcasting licence under the 1960 Act under which the Minister vested power in RTE alone to set up and broadcast.

"It is correct to say no regulations were set up under the 1926 Act because it had never been in question to issue to any independent broadcasting authority a licence to broadcast or to anybody other than RTE", said teh spokesman.

"In fact, if a broadcasting licence were to be issued to anybody else, the 1960 Act would have to be amended to begin

The good news is that Radio Clonmel will be back on the air in July with better equipment and a higher powered transmitter News from Cork is that the Cork Broadcasting Company has commenced broadcasts followed by Cork City Radio .. In a 'Starlight' issue Dated March 16th - the 'Tune In8 feature (sounds familiar eh!) carried an interview with Don Moore of ARD. He revealed that they were in debt to the tune of £10,000 but hoped to break even

when advertising increases. He also revealed that in April they hoped to open up a station in Cork City Radio Cill Dara (whose story we featured in last edition) had a article in the Irish Press under the heading: "Now Kildare gets a 'community pirate"..... According to a local Israeli newspaper 'Jerusalem Post', the Voice of Peace broadcasting on 1450 kHz was due to close down on February 28th last, following heavy financial problems Latest news on the V.O.P. is that at the time of pinting the station is still on the air The Free Radio Service (Great Britain) is to close down; according to FRS NEWS March '78: "Due to Home Office intervention the FRS of Great Britain is being forced to close down on March 31st. Many thanks to Albert Hood, the Free Radio magazines and Radio CarolingeB.J's who helped us over the past 17 months. Don't be too sad, FRS will be back under a different name and address. People come and go but the in ideals live on.".....At a recent press reception, ARD introduced four new members to their station. They are: Howard Kinlay (Controller of Programmes), Dave Sinclair (Musical Director), Ray McGuigan (News and Current Affairs) and Pat Brennan who will be Press Officer On Wed. March 22nd the Cork Broadcasting Company was raided. However, the station returned to the airwaves the following day via a standby transmitter News from Downtown Radio Dublin is that soon they are to open up on a new wavelength of 259 metres On Monday, April 10th at 8.15am Dublin's newest Free Commercial Radio station took to the airwaves. Titled 'THE BIG D' it broadcasts on 273 metres medium wave. It is the only station in Ireland that broadcasts 24 hours per day. A number of ARD D.J.'s have joined the setup - the number standing at six at the time of pfinting!! The FRC-IRELAND SHOW now comes via the BIG D studios in Chapel Lane.....

RADIO DUBLIN NEWS RAP..... At a Dublin City council meeting of March 6th, Mr. Sean Moore, T.D. invited Radio Dublin to close down to enable the Minister for Posts and Telegraphs to meet their representatives. The Council was debating a motion put forward by cllr. Paddy O'Mahony, calling on the Minister to meet the Directors of Radio Dublin. Strong opposition came from a number of councillers, led by Mr. Pat Carroll who called commercial radio 'a licence to print money'. He also said that RTE would lose advertising revenue and might have to compensate for this by increasing the licence fee. He admitted RTE was 'very dull' (?!?) and suggested that Radio Dublin should be under public ownership and have a charter different from that of RTE..... Meanwhile, on the following day (March 7th), Eamonn Cooke owner of Radio Dublin, was fined £35 in the Dublin District Court on two summonses under the Wireless Telegraphy Act 1926. A third summons alleging use of illegal wireless telegraphy equipment was withdrawn. District Justice Joseph Plunkett ordered the confiscation of equipment, valued at £40, seized from Eamonn Cooke's home at Sarsfield Road, Inchicore on January 17th Radio Dublin were banned from the St. Patrick's Day parade. No reason was given by the organisers Good time had by all at the R.D. family fun day out at Mondello Park on Paddy's Day. NEWS FROM ALTERNATIVE RADIO DUBLIN 257 METRES.... ARD's new schedule became operational on Monday, April 17th 1978. Some of its features include an increase in our current affairs and speciality programmes. For example, on Monday nights we have a consumer programme called "CHECKOUT". On Tuesdays we have "LIVE ISSUE" which focuses on one topical subject. "SOUNDINGS", the new arts programme, is on Wednesdays. On Thursdays we present "LOCAL LINE" - this programme investigates the issues affecting Dublin's communities and on Friday we have a special programme which looks at the local sports scene.

Our music schedule has been increased to include special programmes on traditional mucic, jazz, progressive sounds, rock 'n' roll and the 78 Show (that's 78 R.P.M.'s). On Saturday nights JOE BREEN, of the Irish Times will present a rock programme.

We have expanded our hourly news service to begin with headlines at 7.30am (broadcasting begins one half hour earlier at 7.00am) and includes a lengthy news bulletin with interviews with 'names in the news' at 1.00pm.

Broadcasting now continues until 2.00am each morning, except Saturdays when the D.J.'s will keep things going straight through the early hours.

ARD 257 IS YOUR RADIO - MAKE IT HAPPEN IN 1978:

SHE calls herself Jaqueline Young and she's disc jockey, financial controller and the only girl working with Cork's newest pirate radio station.

And like the others involved in Cork City Radio, she's extremely secretive about the location of the station and the people behind

"We're all using false names," she admitted with a grin. "I'm not saying what mine is — in fact I don't even like it — and the others feel the same way. And because of the constant fear of being raided, we're not prepared to say where we broadcast from, except that it's a Cork suburb."

The station goes out on 199 metres, medium wave. On the air from 7 a.m. to 9p.m., Jaqueline and her boyfriend Peter Martin another stage name — hope to run a 24-hour service shortly.

Cork City Radio features phone-ins, street interviews and hourly news bulletins. "We try to cater for all tastes, by playing everything from classical to pop," said Jaqueline, who used to work in a record shop.

"At the moment, any money we make from advertising is going towards more equipment, in case we should be raided. We intend to keep going, whatever happens, but I can't see the Government suddenly

deciding to make all the pirate stations 'legit'. If we're caught, we'll fight the case," declared Jaqueline.

IRISH PRESS - MARCH 2424/978 Broadcasting Act challenge by Cork radio pirates fails

Cork at the end of January last were refused an injunction by Mr. Justice Hamilton in the High Court in Dublin on Thursday. They complained to the court that members of the Gardai and officials of the Department of Posts and Telegraphs had gone to their studio, produced a search warrant and seied equipment.

The men, Stephen Bolger, described as a radio broadcaster, Daniel Walsh and Con McParland, of Farley Place, Montenotte, in an action against Ireland, the Attorney General, the Minister for Posts and law; you are asking me to Telegraphs and Sergeant John McGuire, are seeking a declaration that those provisions of the Wireless Telegraphy Act, 1926, which provide for the seizure of broadcasting equipment are unconstitutional and contrary to natural justice. They are seeking a mandatory injunction directing the defendants to hand over their seized property and an order prohibiting any further such seizure.

Stephen Bolger, in an affidavit, said that the three plaintiffs had formed a partnership called the Cork Broadcasting Company, operating from a studio at 7 Farley Place, Montenotte, where they transmitted popular music to an audience within a radius of about 10 miles.

On March 22, Sgt. McGuire with other gardai and officials called to the studio, produced a search warrant and seized the equipment. On Thursday they had remused broadcasting with the aid of borrowed equipment.

The application was made by Mr. James O'Driscoll, S.C., who was told by Mr. Justice Hamilton that, until proved otherwise, the court must presume that the provisions of the Act were constitutional. "You are asking me to permit your clients to continue to be in breach of the restrain the State from enforcing the law," he told Mr. O'Driscoll.

Mr. Justice Hamilton said that one was not entitled to have protected businesses which were being carried out in clear breach of the law. This Act had. been in existence since 1926.

Mr. O'Driscoll's clients were fully aware of its existence but in spite of knowing this they had set up a broadcasting system. However, the headlines of the Dublin papers showed that abortive was not the case with regard to the raid on BIG D RADIO, Thursday, June 15th. As the 'Evening Press' stated: "P.O. MEN BREAK INTO PIRATE RADIO H. Q. " They literly broke up the premises - hacking down the walls ... "when they came in they just smashed everything they could find.

They tere down ceilings and walls as some of their colleagues carried out the equipment." "They just did not seem to be interested in summonsing us or taking away the transmitter, but also in tearing down the whole premises" said D. J. ROSS TALION who was present at the time of the raid. There can be no doubting that this tactic by Department of Posts & Telegraphs represents a new 'get heavy' approach to suppressing freedom. Perhaps they are just desperate, or acting under strict orders from above ? One thing for certain, independent commercial radio is here in Ireland to STAY.
